Board adopted these additions/deletions at their June 9th meeting and they were published in the ALCONA COUNTY REVIEW on June 16, 2010 with an effective date of June 24, 2010.

NEW BUSINESS:

Proposed Condominium Ordinance – Hahn and Freigruber will research this issue further. Language re PUD's will also be researched.

Review Zoning as it applies to the Master Plan adopted June 14, 2006 to include preservation of agricultural, forest and recreation land -- Proposed Forest/Recreational and Residential/Agriculture changes will be incorporated in the Zoning Ordinance revision. Freigruber will draft a recommendation for the new Zoning Ordinance Book.

Chain Link Fence Definition -- Williams still researching -- there are numerous variables to consider.

Setback Requirements to Prevent Obstructed Lakefront Views – Waldeck to review and research.

POLL MEMBERS FOR NEW BUSINESS: Preston will research natural screening fences. Will determine if ordinance should include reference to medical marijuana dispensaries.
