- V. Public Comment: (3 minutes uninterrupted): Jim Klarich wanted to thank the board for everything they do for the township. He would like to bring to the boards attention short term rentals in the area. The fact that lake property is being bought up for the sole purpose of VRBO. On Oak street where he lives there are the 5 houses including his; 2 are full time residents and the other 2 are VRBO with another one coming. This is a wake up call to address it. The township needs to be concerned and hopes the township will address this.
- VI. Supervisor Report: Bases are in place at the Spruce Ball Diamond. We need to consider a fence on left field side so stray balls are not going on neighbor's property. Met with FEMA and working on collecting receipts and hoping for reimbursement.
- VII. Clerk: Reported Alcona Schools is being billed \$3,344.62 for the Special Election.
- VIII. Meeting Minutes April 8th, 2025: T Tice made **motion** to approve minutes as presented. Seconded by A Sobeck. All in favor **Motion Passed**
- IX. Treasurer Report: State of Michigan deposit received and she will move into Money Market Account.
- X. Planning Commission Update: A Sobeck reported there was no meeting. There was homework of looking into VRBO and how other Lakes in Michigan are handling them.
- XI. Veterans Representative: Jim gave a reminder3 on Memorial Day being May 26th. It's a day of honoring and mourning those who died for our country. 1971 law declared as a Federal Holiday and in December 2000 congress passed an Act to observe a moment of silence at 3pm where ever you are at. There is a purpose to remember fallen soldiers. Do not wish anyone a Happy Memorial Day. This is not Christmas or a joyful occasion. Someone lost a loved one. We can fog seal it for now for \$61,466.00. A. Sobeck made a **motion** to enter into contract with Alcona County Road Commission for fog sealing not to exceed \$61,466.00. T Tice seconded. - XIV.Possible Recommendation for Planning Commission: Board discussed concerns about VRBO or short term rentals on lake.The board agrees to have the planning commission look into this and make a recommendation to the board.

- XVI. Grant: We have filed for the final draw from the grant for NE Park.
- XVII. Building Cleaning: Tyler Purdue pressure wash/steam clean for NE Park buildings. \$200.00 for one time. A Sobeck made a **motion** to hire Tyler Purdue to pressure wash buildings and stand alone bathrooms and sidewalks for \$200.00. T Tice seconded. All in favor **Motion Passed.**
- XVIII. Storm Clean-up: Myer Lawn Care is currently cleaning up and is on site on the properties.
- XIX. Port a Potty at Tollson: Alpena Septic charges 200.00 and is in township and Wilsons in Hale is 175.00 a month. C Smith made a **Motion** to hire Alpena Septic for port a potty rental at \$200.00. T Tice seconded. All in favor. **Motion Passed.**
- XX. Township Newsletter: Haylee wanted to add a newsletter to the tax bills. Has to be ready by 06/10/2025. Board Agrees.
