Public Comment from the floor — Julie U. stated comments are based on my observations. Tollson Park and Holcomb Creek, have become controversial topics for residents and the Board over the past 4 months. Tollson Park in June, area residents became aware of the Board's intent to transition the property. Tollson Park neighbors appeared at the July 10th meeting to ask questions regarding our concerns. These questions were submitted in writing to the Supervisor which included parking, liability, and neighborhood security and what are the short and long-term goals and plans for Tollson Park? The Board advised us that they were simply cleaning up the site and there was no plan.—Twp. Attorney attended the meeting regarding private versus public use of the site which was never an issue. Details of Tollson Park have never been discussed, yet changes continued at the property with motions being passed at a special meeting after the fact. That is not how it's done with a public entity financed by taxpayer dollars. Tollson Park and Holcomb Creek controversies could have been avoided by formation of an ad hoc committee. In closing, after observing this Board over a four month period, I have seen pre-determined decisions presented without discussion with motions made after the fact over and over again. I find this pattern to be highly unethical and most likely in violation of the Open Meetings Act. As a taxpayer, I find both of these scenarios to be unacceptable and sincerely hope that the Board will aspire to a higher ethic in the future.
