

Caledonia Township Board Of Trustees – DRAFT Regular Meeting Minutes

- I. Call to order: C. Apsey presiding and called to order at 7:01 pm
- II. Pledge of Allegiance – Completed
- III. Roll Call – Anthony Sobeck; Absent Tom Tice; Present Cyndi Apsey; Present
 Haylee Rondeau; Present Cindy Smith; Present
- IV. Approval of Agenda with additions, deletions, and/or corrections: H Rondeau made **motion** to approve agenda with changes. T Tice seconded. All in favor- **Motion Passed**
- V. Public Comment: (3 minutes uninterrupted): Rich Gillespie asked where we are in Mockenridge lawsuit and if he can FOIA information. C Apsey said we can't comment as we are still in court with them. He asked how long the tree removal bid is good for. Cyndi replied it is still good. Rich wanted to know where the military flags are and she stated they are stored in the closet. Rich wanted to know where we are in solar. Cyndi replied that until they pull or submit to pull a permit nothing is happening and they haven't done that yet. Rich stated he was asked not to leave business signs in the right away of roads but it appears other businesses are still doing this.
- VI. County Commissioner: Dave Jacqst reported that Consumers bought out another solar project so they are focusing on that project. Stated there is only one year left on the current contracts. Dave reported that broadband is coming to the area. As a county we did amazing with all the letters and support. They have 4 years to complete project. There is another high speed internet coming to Harrisville, Lincoln, LLWC, and Hubbard Lake, will come through Spruce.
- VII. Supervisor Report: Cyndi reported Mt Maria paving project is completed over 3 townships. The new posts for signs were installed at Tollson Park. The dead Oaks at NE Park will be removed within the next month.
- VIII. Meeting Minutes September 9th, 2025: C Smith made **motion** to approve minutes as presented. Seconded by T Tice. All in favor – **Motion Passed**
- IX. Special Meeting Minutes October 8th, 2025: T Tice made **motion** to approve minutes with corrections. Seconded by H. Rondeau. All in favor – **Motion Passed**
- X. Any other business: C Smith reported off year audit was completed and report came back really well with no issues. C Smith also reported she completed grant paperwork from Bureau of Elections to get reimbursed from the state for new election computer.
- XI. Treasurer Report: Haylee Rondeau reported moving money to money market account.
- XII. Planning Commission Update: A Sobeck absent.
- XIII. Veterans Representative: Jim stated he is pleased to report all the grave markers/headstone of all the Veterans interred at Pleasant View have been cleaned and leveled. That's 210 stones. There are two bronze markers with no foundation. As of 10/10/2025 someone put a marker on the ground with no foundation and no hardware. Just sitting on the grass. Jim removed it until he can get a foundation and hardware to install it correctly.
- XIV. Fire Department: Cyndi reported that the public meeting was put on hold for a one on one to try to help to resolve the separation of Volunteer FD to separate from HLCA. HLCA initially declined than later accepted. They are currently in talks.
- XV. Snow removal Bids: Only bid received was from Myers Lawn Care for same rate as last year. C Smith made a **motion** to hire Myers Lawn care for 2025-26 season. H Rondeau seconded. All in favor – **Motion Passed**.

XVI. Sexton Position: Tabled to next budget year.

XVII. Bills to be Paid: T Tice made a **motion** to pay bills as presented. H Rondeau seconded. All in favor – **Motion Passed.**

XVIII. Board Comments: Cyndi Apsey talked about doing community dinners and the first one is scheduled for October 23rd, 2025 at 6pm at the Township Hall. No township funds will be spent on this, all volunteers. Free to the public. If anyone needs a ride please let Cyndi Apsey know.
