- I. Call to order: C. Apsey presiding and called to order at 7:03 pm
- II. Pledge of Allegiance – Completed

- IV. Approval of Agenda with additions, deletions, and/or corrections: T Tice made **motion** to approve agenda with changes. A Sobeck seconded. All in favor- **Motion Passed**

- VI. Commissioner: Dave Jacqst reported that the County has contracted with Alpena to hold inmates for Alcona Co. The Iosco contract tripled in price. Septic code is still with the State. Also, Alcona county is looking to hire an electrical inspector for 1-2 days a week so if anyone is interested, please reach out to Alcona county.
- VII. Supervisor Report: FEMA update was just signed for the Management Grant, which is for time spent applying or researching, meetings, and so forth. These grants are a 75% match. So the township received 75% for each grant from the actual occurred costs. The totals that the township is receiving are Management \$697.92, Generator/Hall use \$7,093.80, Damage Clean up \$3,375.00, and donated hours of \$3,489.60. Donated hours are board member and their family's hours This money is going to the township not to the people who donated their time.
